In-Person / Online Learning Program: Programs that deliver learning entirely through the internet/online. Examples of individual learning programs include but are not limited to reading, math, coding, foreign languages, spelling, science, art, social studies.

Uniform Vendors: Vendors that supply school uniforms. These vendors must be approved by a qualified private school.
